Collective investments - our share of any initial charge will be rebated

A compliance charge of £2.50 will be levied on every transaction

Traded Options

UK, European, Swiss and US equity and index options £40

plus £2.50, €3.50, CHF6.00 or \$4.00 per equity and index contract opening and closing

Commission on Assignment/Exercise - Half equity execution-only & advisory commission rate

Other Charges

Overseas dealing may incur local charges which will be passed through

Stamp Duty is levied at 0.5% on the total consideration value of the purchase of UK equities

Stamp Duty or other government charges may also apply on certain overseas securities where local rates shall apply

An overseas settlement fee is applied to non-Crest equity and fixed interest trades. This is typically £22.50 but varies with depository

General administrative matters carried out by GAM	£60 per hour

Note: Our custodian, Jarvis Investment Management Limited, debits a custody fee to your account for all securities held outside of CREST (excluding unit trusts not held in a depository). This is typically 5bps of the market value of the security per year, subject to a minimum of £36 (for Euroclear & DTC)
